2011-2012 PLAYER/PARENT CONTRACT

Congratulations on being selected as a team player **for PINECREST PREMIER SOCCER CLUB** for the **2011-2012 Seasonal Year!** As part of the registration process we want to insure that you are fully aware of, and understand, the commitments Pinecrest Premier soccer Club makes to you, and what our expectations and obligations from you are, as a result of your accepting the position offered to you. Please sign at the bottom below acknowledging your understanding of the mutual expectations between you and Pinecrest Premier Soccer Club, then sign and date below.

We understand that a registered player is obligated to his/her team for the entire seasonal year. We understand that accepting this offer to join Pinecrest Premier Soccer Club and completing the registration documents obligates me to pay the full registration fees of **\$480.00 (four hundred eighty dollars)** regardless of whether we later decide to leave Pinecrest Premier Soccer Club prior to the end of the seasonal year. We understand there are no refunds of the registration fees.

We understand that since this is a premier competitive environment, there CANNOT be any guarantee of minimum playing time on the field. We also understand and agree to abide by Pinecrest Premier Soccer Club's policy of not allowing players to guest play with other teams or members of other teams to guest play with Pinecrest Premier Soccer Club teams, except with express written approval of the team's respective coaches as per FYSA guest player rules. These exceptions will only be granted if all player's fees and financial obligations have been fulfilled.

We understand that failure to fulfill our financial obligations to Pinecrest Premier Soccer Club may result in the player being placed "Not In Good Standing" with Pinecrest Premier Soccer Club and FYSA, which will result in the player's playing privileges being suspended until the obligations are fulfilled. This will also impact the player's ability to register with Pinecrest Premier Soccer Club or any other affiliate next year.

We understand that any fines team incurred during the year is the responsibility of the team and the coach.

WAIVER OF LIABILITY AND DISCLAIMER

I, the parent or legal guardian of the named player, acknowledge that I am completely aware of the inherent risks associated with soccer, and hereby waive, release, and discharge the state association (Florida Youth Soccer Association, Inc., "FYSA") and all of its affiliated organizations, Pinecrest Premier Soccer Club, as well as their officers, directors, employees and agents (collectively, the "Released Parties"), from any and all liability and responsibility in the event that my child becomes injured in any way during his/her participation in soccer events or activities associated with the Released Parties. I further state that I take full responsibility for any injury that may occur as a result of my child's participation, and that I will not hold the Released Parties responsible for any aggravation of preexisting injuries prior to or during his/her participation in any soccer events or activities associated with the Released Parties.

EMERGENCY AUTHORIZATION

I, the parent or legal guardian of the named player, authorize Pinecrest Premier Soccer Club, its volunteers, employees or representatives to act as my agent(s) to consent to medical, surgical, or dental examination and/or treatment at a hospital or other health facility in an emergency where I cannot be reached. I verify the named player has no injury or other condition which would affect his/her ability to participate, or that I have advised in writing to this organization, of that condition, including my physician's name, and confirm the ability of the named player to participate regardless.

We have read the **FYSA Code of Ethics** as printed below, and agree to abide by the requirements. We will act in a manner of respect at all practices, games, travel, etc., and serve as role models to others to maintain the integrity of ourselves, our team, and all of Pinecrest Premier Soccer Club. Players will conduct themselves in accordance with **Pinecrest Premier Soccer Club, FYSA, USYSA, USSF, and FIFA** rules at all times, or will be subject to disciplinary action.

I affirm the named player is covered by primary health insurance.
